3. Applicant must submit a complete dossier giving detailed information on their organization and activities.
4. Applicants must submit the following:
 - a. The Constitution and By Laws of your organization;
 - b. The complete profile of the Management Committee. (Please include photocopies of their qualifications with signature certifying them to be true copies);
